Title: <u>Drinking Water Planning and Design Funds for PFAS Treatment</u>

#### **SCOPE OF ADDENDUM**

The RFP is revised as follows with strike through for deletions and underlining for insertions:

#### **Revision 1**

In the RFP, page 1, Section 2, "Funding" is amended as follows:

A total of \$22,000,000 in funding is available. This RFP will remain open, and applications will be accepted on a rolling, first come, first serve basis until all dedicated funds have been awarded or **4:00 pm Central Time on <del>Monday, September 30, 2024 Monday, June 30, 2025</del>, whichever occurs first.** 

#### **Revision 2**

In the RFP, page 1, Section 1, "Overview" is amended as follows:

The legislature approved a one-time appropriation for the planning and design for long term treatment of public drinking water contaminated with PFAS. This is a one-time appropriation and must be spent by June 30, 2027.

This funding opportunity provides up to \$22,000,000 (twenty-two million dollars) total to support planning and design of drinking water treatment systems or alternative contaminant free water source options for those communities that meet the eligibility criteria.

### **Revision 3**

In the RFP, page 2, Section 4, "Eligible and ineligible projects" is amended as follows:

Eligible projects must plan and/or design drinking water treatment systems to address PFAS contamination <u>or</u> <u>alternative contaminant free water source options</u> for public water supplies. Costs should include PFAS treatment, necessary pretreatment for PFAS treatment, and water distribution system upgrades associated with PFAS treatment.

## **Revision 4**

In the RFP, page 3, Section 6, "Application submission instructions" is amended as follows:

All applicants must submit the Rolling Application Form. Applications must be received electronically by the MPCA **no** later than 4:00 pm Central Time on Monday, September 30, 2024 Monday, June 30, 2025.

#### **Revision 5**

In the RFP, page 3, Section 7, "Application questions" is amended as follows:

The MPCA is obligated to be transparent in all aspects surrounding grant work. To meet this obligation, all questions must be submitted in the same manner. Applicants who have any questions regarding this RFP must email questions to

## **Revision 6**

On page 5, Exhibit A: Application eligibility assessment sheet, "Eligible projects" is amended as follows:

Planning and designing of treatment systems to address PFAS contamination <u>or alternative contaminant free water</u> <u>source options</u> for public water treatment systems.

## **Revision 7**

The Application is amended as follows:
